Dear Committeeman Eggemann:

We, the undersigned, write you today demanding that you hold the Republican Party members to the same standard of conduct, decency and ethics that you do of the Democratic Party. It has come to our attention that your endorsed candidate for the 55<sup>th</sup> District is calling for the resignation of Mike Madigan for allowing sexual harassment to occur in the Democratic Party and the State Capitol. As you can see in the attached RWOPR Facebook shared post of October 31<sup>st</sup>, 2017, all of your slated candidates "applaud the strength of the individuals coming forward with their experiences, as well as all who are speaking out against this abhorrent behavior". However, no such hue, outcry and demand has been made of one of the Republican Party's officials, namely, Maine Township Trustee David Carrabotta, despite clear allegations of such by a fellow Trustee, Kimberly Jones, whom you previously slated. As you are well aware, in the cases of Kevin Quinn, Tim Mapes and Lou Lang, it appears swift condemnation and removal from their positions was done immediately. In all those cases, the harassment was verbal. In this case, the alleged harassment is actual groping yet you and your fellow Republican Women of Park Ridge and Republicans of Maine Township have been strangely silent. Not only have you not moved to condemn this behavior, your leadership group embraced Trustee Carrabotta after these public allegations by having him be the standard bearer of the flag of the Republican Women of Park Ridge in the Memorial Day Parade.

This is frankly outrageous and disturbing, and we write you today to demand of our leadership to condemn such behavior and call for his resignation immediately. As you are well aware, Kim Jones has a stellar reputation in the community with 30 years of service in State and local government, which you recognized by choosing her as one of your precinct captains as well as choosing her to literally be one of the first people you

chose to slate for the Maine Township elections. Your silence is deafening.
