Hello,

It has come to my attention that former library officials have objected to my reappointment to the Library Board of Trustees based upon meeting attendance.

I want to assure both of you, the Mayor's Advisory Committee, and the City Council that there is no need to be concerned with my attendance – past or future.

Board Meetings

I travel in my professional life, and have made it a point to avoid business meetings (which would benefit me personally) that may conflict with Library meetings. <u>I have only missed 4 Board Meetings</u>

during my entire three years; my attendance rate is 89% through May 2016. Moreover, I've had perfect Board Meeting attendance for the last two calendar years – 2015 and 2016.

This is a reflection also of greater predictability in my work schedule, which has only came about in late 2014 and will continue in the future.

Committee Meetings

At the inception my term in 2013, Committee assignments had not yet been made. As a result, previously-scheduled work commitments took precedence over committee meeting dates which were not previously known to me. In my line of work, it is typical to schedule meetings 120 days out or more, so this of course could not be helped.

Another complication in respect of Committee meetings was the Tuesday/Thursday Committee meeting schedule prior to the Board's adoption of the Committee of the Whole ("COW") structure. This, too, made it difficult to attend. Since the COW structure was instituted in October 2014, my Committee Attendance record is 77%. It is likely that the COW structure will remain in place moving forward, so Committee Attendance is a non-issue.
