*9. APPROVAL OF BIDS AND AWARDING OF CONTRACTS

A. George K. Baum and Co. - Community Engagement

Resolution: That the Board of Education enters into a contract with George K. Baum and Co. for community engagement for future school remodeling projects at a cost of \$75,000.00 as detailed in the agreement.

The District went out for RFQ for community engagement companies. The responses were narrowed to two firms who went through an interview process. The clear choice of the committee was George K. Baum. They work in tandem with Public Opinion Strategies and Marsha Sutter. Once the contracts are approved, a timeline will be developed.
